### Name Sorting

Tired of looking through 1000 cases to find what you are looking for? CourtTrax will soon have the ability to sort your name searches in several ways, easing the burden of finding the case(s) you need. This will be launched initially in the Federal Courts, with our available state courts following shortly thereafter.

### One Click Only, Please!

When reviewing the results of a Name Search in CourtTrax, make sure you are clicking desired Case Number links only **once!** Case data is retrieved from the court once for each click of a case link; double-clicks can accidentally lead to double-billings.

### The Power Of The Comma

Did you know that you can search multiple cases with a single click? When conducting a Case or Judgment number search, try entering in more than one case number, separated by a comma and a space (i.e. 09-2-01235-6, 09-3-04126-3, etc.) CourtTrax will initiate a search for each case, and all will appear as separate entries on your Saved Searches report once they individually complete. More data with less time and effort. That's what CourtTrax is all about!
