

Electronic Access to King County Documents

CourtTrax is pleased to announce the launch of its electronic document retrieval service for King County superior court documents. CourtTrax's case detail reports for King County cases filed after November 2004 will now have a document section containing links to the documents in the case. You can save time and money by downloading documents directly through CourtTrax.

The CourtTrax interface offers several advantages. First, a relevant client/matter number or search title is attached to every document you retrieve for the file. This makes it easy to pass through the cost of retrieving the documents to the client.

CourtTrax also offers the capability to simultaneously download and print multiple documents. You can actually download all the documents for an entire case docket with two clicks. Most importantly, you can request a case detail report and download related documents literally in seconds.


Pricing

As an introductory offer, King County documents are available starting at \$0.22 per page. Volume discounts are also available, contact CourtTrax for details.

Pulling Documents

Case documents are available from your CourtTrax case detail report for cases in King County. Simply check the box next to the document that you are interested in and then click on the "Get Documents" button at the bottom of the Documents Section. This will generate a Viewable Documents Report that will include all documents retrieved for that specific case. From this report you may simply view the document(s), save or print the document(s) as a PDF, save the document(s) as a zip file, or return to your case detail report.

All retrieved documents are saved in your Saved Search report along with all your other searches. The title of the search will include the client/matter number or search title attached to the original case detail report as well as being clearly labeled as documents. If documents have been retrieved for the same case previously, the most recent Viewable Documents Report will also include all previously downloaded documents.
